The Toys-R-Us Team was able to identify and track down a group traveling the country using rental vehicles, that were targeting high end electronics from stores across the country. The Toy-R-Us team coordinated with their counterparts and law enforcement from coast to coast, to locate and apprehend 4 suspects who had stolen tens of thousands of dollars of merchandise in 5 days. They were also able to partner with law enforcement to intercept shipments and recover \$20,000 in stolen merchandise.

Diamond Diva And Accomplice Sentenced


An aspiring model - dubbed the Diamond Diva - allegedly trained for months before stealing over **\$4million** worth of jewels in a series of armed robberies.

Abigail Lee Kemp, 24, is accused of carrying out six raids on jewelers across five states - Georgia, Florida, South Carolina, North Carolina, and Tennessee.

But authorities say she did her homework

before allegedly carrying out the crimes - learning how to handle a gun, zip tie a victim and even secret code words.

Now, she and one of her accomplices have been sentenced.



Kemp, 25, will spend a decade in prison while Gilmore, 44, was given the much lengthier sentence. They also were ordered to pay \$1,499,690 in restitution. The two, along with Lewis Jones III, 36, and Gilmore's brother Michael, 47, all had been charged in robberies across the South.

"I am truly sorry for everything I've done," Abigail Kemp said Friday. "Not a day goes by that I don't think about the victims. I pray for them every single day. I hope one day they can live in peace."


However, Kemp's remorse and cooperation with the trial had to be balanced with the impact the robberies had on the 13 victims, Prosecutor Katy Risinger said. Mark Neapolitan, a representative for one of the jewelers

affected (and CLEAR Board Member), said at the sen-

tencing that some employees never returned to work after the robberies.

"These people will never be the same because of Ms. Kemp's actions," Neapolitan said. "The armed robberies were cold and calculated direct actions. They were not committed for any reason other than greed."
